PROPOSAL: The Federal Aviation Administration (FAA) has received a request to decommission the Yoakum (OKT) Non-Directional Beacon (NDB), located on the Yoakum Municipal Airport (T85) near Yoakum, Texas. The OKT NDB is owned and operated by the City of Yoakum. Kevin Coleman, City Manager, has notified the FAA of the City of Yoakum's intent to decommission the OKT NDB due to the following reasons:

- The OKT NDB is in need of extensive repairs
- The OKT NDB is no longer needed due to technology advances
- The City of Yoakum plans to reallocate the OKT NDB maintenance and repairs funds to other areas of the Yoakum Airport

This device will be removed without replacement should the study show that the decommissioning the OKT NDB would not be detrimental to the National Airspace System.

The Central Service Center Flight Procedures Team stated the Yoakum (OKT) NDB decommissioning IFR Effect will be added to the SW Region RAPT agenda. This includes scheduling the cancelation of the NDB RWY 31 at Yoakum Muni (KT85) and the facility charting on the VFR Sectional, Low Altitude Airway chart, and the Controller charts will also need to be removed.
